POLICIES DUE TO COVID-19

- Appointments will be one client per hour.
- Our staff will be wearing masks and gloves and clients are required to do the same when walking into our partner sites and our office.
- The required DCF Food Stamp Interview will be completed mostly over the phone. Therefore, interaction with our clients will be minimal and brief, only to obtain signatures and collect documents, and within 6 feet from each other to follow the social distancing guidelines. We will follow up over the phone if needed.
- All clients are expected to arrive on time to their appointment time booked, not before or after.
- If you are sick, please **do not book** an appointment.

Due to COVID-19, DCF has implemented a six-month recertification extension for individuals and families scheduled to recertify in April or May. It's important to remember that only U.S. citizens and certain lawfully-present non-citizens may receive SNAP benefits. Non-citizens who are eligible based on their immigration status must also meet other SNAP eligibility requirements such as income and resource limits. Thus, DCF has not implemented emergency food assistance at this time. However, if you believe that you or somebody in your household is eligible and want to apply for food stamps for the first time, please be specific and state that in your message. Leave your name and phone number and your call will be returned within the next 72 hours. Please do not call more than once. Thank you!

Debido a la crisis del coronavirus, DCF ha postergado las renovaciones hasta dentro de 6 meses a todos aquellos que ya reciben cupones de alimentos y tienen su renovación programada para los Meses de Abril y Mayo.
